3	Reviews of activities
	 Coordinator, IQAC presented report of internal Academic and Administrative Audit conducted for the semester. The committee members reviewed various activates, rubrics of quality programs implemented. The committee members suggested to implement an online Suggestion Box by IQAC to obtain additional comments, questions, and requests.
4	Placement and Training
	 Committee confirmed the campus placement drives, companies visited the campus and number of students recruited. A discussion raised on preparation of a separate training schedule for training final year students. Suggested to invite more corporate trainers into the campus for training the students. The member from industry explained the current trends of the industries.
5	Outcome Based Education- Enhancements to existing practices.
	 Chairperson conveyed the members regarding implementation of Outcome Based Education (OBE) format for designing and evaluating the internal examinations. Further quoted that in addition to existing practices of OBE, the departments are encouraged to derive COs, POs, PEOs, CAT & GAP Analysis to all the subjects.
